

**Boise State University BARK IN THE PARK (“Event”)  
ATTENDANCE WAIVER AND RELEASE**

I \_\_\_\_\_ (hereinafter “OWNER”) acknowledge with my signature below my voluntary participation in the Bark in the Park (hereinafter “EVENT”) and that I am over the age of 18 and responsible for the conduct of myself and my dog. In signing I understand that I must show veterinary proof of current vaccinations and agree to all limitations and guidelines set by the Boise State University staff; and that failure to do so will result in ejection from the park. I understand that my dog must remain leashed and in my control at all times from arrival at EVENT until departure. My dog is in good health, poses no threat to other participants or their owners and has current vaccinations. I have carefully read the Guidelines for the Event and I agree to comply with them as they apply to my dog, my guest(s) (if any) and me.

1. I understand the nature of the EVENT and I am fully aware of the risks of unexpected injuries, damage or other loss that may result from my participation in the EVENT. (E.g. dog bites, fights, falls, or contacts with other dogs or spectators.) I freely assume all such risks including the risk of any negligence by other participants, I agree to levy no fault to Boise State University, any of the organizers or volunteers of the EVENT or any other participants in the EVENT. As defined below, including without limitation, the risk of dog bites.
2. I hereby release from liability, waive any claims against, forever discharge and hold harmless Boise State University and each of their respective affiliated departments or other organizations, volunteers associated with the EVENT, the organizers of the EVENT and each of their respective officials, owners, partners, directors, officers, trustees, members, employees, representatives and agents, and the other participants in the EVENT (collectively, the “Released Parties”) of and from any and all claims for injuries, disability, death, property damage, attorneys’ fees or other loss of any kind or nature that may be sustained in connection with my and/or my dog’s attendance at or participation in the EVENT or any activity surrounding the EVENT even if based on the negligence of any Released Party. I further agree not to sue any of the Released Parties for any such claim.
3. I, as OWNER understand that my dog will not be permitted to enter the EVENT until and unless I agree to accept full responsibility for my dog and certify that the dog is current on all vaccinations. (E.g. DHHL, Bordatella & Rabies vaccinations.) I, therefore, shall be fully responsible for any and all injuries and/or property damage caused by my dog, my guest(s) (if any) or by me and I shall indemnify, defend and hold the Released Parties harmless for any such injuries and/or property damage. I understand that my dog may be subject to ejection or not allowed into the event if he/she shows signs of aggressiveness towards other people or dogs.
4. In connection with any injury I (OWNER) or my dog may sustain or other medical condition I or my dog may experience during my participation in or attendance at the EVENT, I authorize any emergency first aid, medication, medical treatment or surgery deemed necessary by the attending medical/first aid personnel if I am not able to act on my own behalf. I further authorize the attending medical/first aid personnel to execute on my behalf any permission forms, consents or other appropriate documents relating to medical attention for me or my dog and to act on my behalf if I am not able or immediately available to do so.
5. I authorize Boise State University to produce, reproduce, broadcast and otherwise use photographs, films, recordings, digital images and other depictions, likenesses or images of me and my dog, in any media form, in connection with my attendance at or participation in the EVENT without compensation, for an unlimited duration.

I, intending to be legally bound, have carefully read and voluntarily agree to this Waiver and Release and I understand its full legal effect.
