Animal Care & Control Clerk

The Idaho Humane Society is a community-supported open-door facility that provides shelter, medical care, adoption services, humane law enforcement services and much more to over 20,000 animals annually. Position Summary:

The Animal Care & Control Clerk (customer service) is responsible for assisting the public at our Dorman Street facility. This includes answering phones, processing animal intake and redemptions, and assisting in lost animal searches.

Duties and Responsibilities

- Greet customers upon arrival with a friendly and welcoming attitude
- Process animal intakes, which includes: strays, owner surrenders, transfers, seized/protective custody, return adopts, and wildlife
- Process redemptions and serve citations, if applicable
- Conduct cat/dog searches via lost reports, online postings, microchips, etc. to reunite animals to their owner
- Complete bite case reports
- Process licensing paperwork
- Accept public donations and provide receipt
- Answer phones, return messages, and direct calls to appropriate department
- Maintain cleanliness of lobby and work areas
- Assist animal control and provide backup to dispatch as needed
- Assist kennel staff as needed

Qualifications

- Required:
 - Excellent verbal, written, and interpersonal skills, as well as organizational skills, attention to detail, and ability multi-task
 - Must be pass a background check and be deputized by Ada County Sheriff's office
 - Strong computer skills (Microsoft Office) and ability to learn shelter specific computer programs
 - Must be punctual and reliable
 - High School Diploma or GED
 - o Sincere interest in IHS mission and vision
- Desired:
 - o Previous animal handling experience
 - o Previous customer service experience

Working Conditions

 Most of shift spent working indoors in air-conditioned/heated building using a computer and phone
